MIGRATION - EUROPE'S STRESS-TEST

CAPTAIN CLARA RACKETE TO SAVE THE LOST HONOUR OF EUROPE

While sipping my morning tea with a sprig of sage under a leaded sky and while keeping an eye on the feeder where the nearby woodland birds land in squadron, I read this on the website of the daily newspaper *Le Soir* which, I am sure, will catch the attention of all true democrats:

"Mario Vargas Llosa-Nobel of Literature is convinced that he will not be the only one to ask for the Nobel Peace Prize for young Captain Carola Rackete when the time comes."

Der Spiegel named *Carola Rackete* **Captain Europe** after this reckless young German scientist saved Europe's lost honour by defying the neo-fascist Salvini, Benito Mussolini's self-proclaimed emulator. Exactly as Princess Antigone did, who once stood up, at the risk of her life, to the arbitrary decision of King Creon who threatened her life with his authoritarian power.

Carola Rackete in interview: *You can get out of prison, not from the bottom of the sea. It is sometimes necessary to resort to acts of civil disobedience to assert human rights and bring bad laws before a judge. I am neither a punk nor an extremist: I come from the German middle class, my universe is the academic world. I have friends in a lot of universities. On board Sea-Watch 2, the first boat on which I was captain, sexism does not exist.*

I am a convinced ecologist, an atheist and a European citizen. Since I was 23 years old, I've been travelling around the world. I don't feel particularly German, I'm in Germany barely a month a year. We grew up with the idea of the European Union and, all too often, we forget how important this institution is.



It should be even more integrated, which would force states to accept the distribution of asylum seekers, instead of making this whole ridiculous circus.

Wasn't it said that Europe was missing a story, a myth worthy of the Asian princess kidnapped by a Greek god with a Jupiterian look metamorphosed for the occasion into a white bull? [Natalie Nougayrède](#) was recently attending a conference in Oxford titled [What Stories Does Europe Tell?](#) *The challenge for participants was to find a single narrative for Europe, or figure out if one was even necessary.* As it is, Europe now has its myth: his Antigone of flesh and blood, its modern-day atheist Joan of Arc, champion of the cause of martyred refugees who drown in the Mediterranean by fleeing the horror of smugglers and above all the cruelty of corrupt regimes to join the continent of human rights.

Carola Rackete, the German captain of the Sea Watch 3 boat, which had been drifting for seventeen days on the Mediterranean with forty migrants on board, rescued at sea, broke a stupid and cruel law, following the best traditions of the democratic and liberal Western world. The League and its Federal Secretary Matteo Salvini do not represent respect for legality, but rather a racist and prejudiced caricature of the rule of law. And it is precisely he and his supporters (too many and not only present in Italy, but also in almost all of Europe) who embody the savagery and barbarity with which they accuse migrants. (Mario Vargas Llosa)

On Friday 12 July, Belgian commercial television broadcast a segment on the news entitled "A Belgian tourist discovers dead bodies on a beach in Djerba". She had just arrived in Zarzis, Tunisia, and discovered a dead body on the beach. *These bodies of migrants stranded on the beach ruin the holidays of a Belgian tourist, who asks to change hotels. (Le Soir)*

The Tunisian coastguard counts nearly a hundred migrants dead following the sinking of a canoe leaving Libya. Their tragic destiny was never discussed at any time. Only the reactions of tourists and the tour operator linked to their stay



appear. The media coverage of this event is deeply shocking. Dehumanization is here at its height

In this sequence, indecency and inhumanity prevail. Everything is designed to focus the viewers' attention on the reaction of a Belgian tourist because the bodies were washed up precisely on the beach where she was on holiday. This dramatic deviation from the moral sense leads to seeing the vacations of European tourists as more important than the inalienable right of all to a dignified life is contrary to the code of journalistic ethics.

To maximize the audience, it seemed appropriate to talk about the distress of "*home-grown*" tourists rather than the tragic deaths of migrants. The absence of ethical criteria in this "*report*" unintentionally highlights the flagrant inequalities between the inhabitants of the "North" and a certain "South". This revolting asymmetry between the "North" and the "South", is responsible for a significant part of current migration.

The representation of migrants in some mainstream media is steadily deteriorating. Presented as threats, victims, burdens or intruders -- and systematically as "*the others*" so different from us . Migrants are no longer recognized as human beings in their own right: they are dehumanized. The responsibility of the dominant media in building our representations on migrants is considerable. By feeding misrepresentations, largely formulated by the extreme right, the media "*alter*" migrants, make any form of identification impossible and contribute to the denial of solidarity.

Will Charles Michel, Belgian unloved numero uno, newly appointed President of the European Council, have the guts to bring Salvini into line and with him the rebels of the Vizgrad group who refuse to take in the refugee quota imposed on them by Brussels? In defending the Marakech Treaty against Francken and De Wever, Charles Michel wanted to be *in the right line of history*? We wish him the best of luck.

The late Michel Rocard, former Prime Minister of François Mitterrand, was once suggesting that Europe *could not accept all the world's misery*. More than fifteen years ago Pim Fortuyn, *leefbaar Nederland's* leading politician, was murdered by an extreme left-wing activist, an animal activist, for daring to claim that, according to him, the Dutch boat was full. He considered that the Netherlands could not welcome 40,000 asylum seekers each year. Merkel, another *weak woman*, had the nerve to welcome one million in 2015.



And what will this other woman do, Ursula von de Leyen, the newly appointed President of the European Commission with a very small majority in the Strasbourg Parliament? She is said to be another iron lady. She is a doctor in medicine, and an economist from the London School and she became Minister for Health and Defence of Germany

Some feel Carla Rackete may prove the Gandhi of modern Europe. That selender young woman in dreadlocks and jersey definitely calls herself less German than European.

And what about this 16-year-old Swedish teenager who has chosen to sacrifice her next school year to campaign against global warming? Another girl....

"WHOEVER SAVES HUMAN LIVES CANNOT BE A CRIMINAL".

The German Federal President Frank-Walter Steinmeier defended the female captain of the "Sea-Watch 3". Steinmeier wiped the Italian government's position aside and declared: *"We can expect a country like Italy to deal with such a case differently"*. After all, Italy is a founding member of the EU. Steinmeier: *"Whoever saves human lives cannot be a criminal"*.

The head of state of the most important EU country is thereby redefining the rules of the game: those who are in the Union must violate laws if higher law require it.

EUROPE NEEDS MIGRANTS

However, prejudices seem to prevail in Europe. *Europe needs* According to Mario Vargas *migrants to maintain its high standard of living, because it is a continent on which, thanks to modernization and development, an ever smaller working population must provide for an ever larger and growing retired population. Spain is not the only country with the lowest birth rate over the year, many European countries follow it closely. Migrants, whether we like it or not, will eventually fill this void.*



And to do so, instead of keeping them at bay and persecuting them, we must integrate them and remove the obstacles that prevent us from doing so.

It is important to remember that immigration represents a great tribute to Europe by the thousands of unfortunate people fleeing the sub-Saharan countries ruled by gangs of thieves and sometimes fanatics who have made the national heritage Ali Baba's cave. In addition to setting up authoritarian and eternal regimes, the latter plunder public funds and leave their populations in poverty and fear. Migrants flee hunger, lack of work, the slow death that life represents for the vast majority of them.

HOW TO TRANSFORM MENTALITIES?

Some will say that this is not Europe's problem?

The truth is that Europe is largely responsible for this.

Neocolonialism has wreaked havoc in the Third World. It has contributed significantly to the fact that it remains underdeveloped. Of course, the blame also lies with the indigenous people who have developed bad habits and were accomplices of those who exploited them. In any case, only the development of the Third World will retain in its lands those human masses who today prefer to drown in the Mediterranean and be exploited by the mafias rather than remain in their countries of origin where they do not see a single ray of hope for change.

A transformation of mentalities is essential in Europe. This can only be done through European education of the kind offered by Eyes of Europe. For the rest, in the future, *it will be necessary to open up the borders to immigration and regulate it so that it is appropriate and not a source of division and racism, so that it does not serve as a springboard for a populism that has had terrible consequences in the past either. WOULD IT NOT BE WISE TO PURSUE A GLOBAL POPULATION POLICY FOR RESPONSIBLE CITIZENSHIP AND PARENTHOOD?

Globalization (technological advances in recent decades have made it possible) is compelling us to think and act in terms of global policy for the planet "earth" that is reaching its saturation point. Michel Lesne, Professor at the Faculty of Medicine of the UCL)

Michel Lesne is advocating responsible citizenship and responsible parenthood. What does this imply in practice?



Every year, currently in August, the press informs us that we have consumed all the resources necessary for normal operation and food for the current year and that we will have to finish the year "on credit", i. e. by taking on the share of the human beings who will follow us!

With regard to the generations that will be following us, it is neither responsible, nor moral, nor ethical to consume *on credit*.

Ethics must be imposed where economic and financial developments in the short and medium term dictate objectives that are contrary to the capacities of the planet "earth" and its inhabitants. Human activity already has disastrous consequences on the global ecological balance, but without a planned policy of demographic decline at the global level, we may be facing an even more dramatic disaster for the "homo sapiens", who have become too numerous on the planet.

In the absence of any drastic policy, by 2050, there would be more than 10 billion human beings , unequally dispersed on the planet!

The largest population increases by 2050 are expected in Africa: from the current 1.7 billion to about 4.4 billion. Asia and South and Central America are also expected to witness significant population growth. It is urgent to raise awareness among our contemporaries, wherever they may reside on our planet, of the seriousness of this demographic challenge.

Each individual has the chance or misfortune to be a "tenant on the land For a few decades ", in places and with means that are very unevenly distributed.

FOR RESPONSIBLE PARENTHOOD

It will now be necessary to educate and train future parents to become "responsible parents

"Having a child" is, in most cases, easy. Without ignoring "the instinct of motherhood or paternity, do these parents have the human and material means to feed them, provide them with dignified accommodation, educate them, offer them adequate schooling and appropriate health care, and guide them towards a rewarding job, so that this child, now a young adult, can, in turn, play an active role in society and benefit in return from its technological and societal advances, which enhance and facilitate life on earth, in search of a better quality of emotionally rich social contacts. In this respect, it is essential to adapt young people's education to the realities of scientific discoveries and to be critical.

Whether it is aware of it or not, Europe is at a decisive turning point for its future. It is facing a double challenge: global warming and migratory pressure.

TO BENEFITS HOME COUNTRIES IMMIGRATION MUST BE ORGANISED

BUT HOW?

Migration currently seems to be the most acute crisis, which can very quickly and at any time lead to a split or even a dissolution of the EU alliance of states.

It consists in the resurgence of refugee migration and the refusal of several EU states to allow these refugees from all over the world to stay in their country.

The UN Charter of Human Rights? On paper it is OK, theoretically.

But in practice only if it is applied by other states - as far away as possible from their own country - the electorate (the opinion and education mob in their own country) must be kept calm and gentle to maintain power - of course with lies, corruption and fraud...". Free international media, more and more turn out to be the instruction-bound media.



To the facts and programs that have to be developed and implemented:

- For peace to return to all of our EU Europe and for no civil war to arise from greed and permanent popular incitement, fraud, nepotism, corruption and theft of subsidies (= theft of people's property), a legal distribution key is a mandatory MUST. This must be done on the basis of a precise calculation - the gross national product (GDP) of the respective country, calculated by the number of the population results in a calculated value per capita of the population.
- So far, Germany has accepted 1.5 million refugees. With a population of 82 million. The average investment in migration is 30 billion per year. Germany's gross national product in 2018 was 3.4 trillion euros.

It is a simple, three-pronged calculation of the ratio between Germany's population (82 million) and gross national product (GDP - 3.4 trillion), the costs of migration (30 billion) and the number of refugees (1.5 million).

Every EU member state has to bow to this key.

- Poorer alliance states can experience a certain compensation through a new subsidy procedure to be developed by the EU Commission.
- Every country that applies for money from the EU must grant EU officials permanent access to the figures in its Ministry of Finance. These EU officials are entitled to check the use of the money at any time, and in the event of misuse to immediately stop any payment.
- In this respect, annual balance sheets are to be drawn up, which are checked by the EU Commission and independent auditors (constantly new ones) in Brussels and then published on the Internet.
- Transparency is required for ALL, and at all times.



Education and Training

- All migrants aged 6 to 60 are required to attend school and receive training from the date of entry into an EU Member State.

Not only the respective national language but also the laws and customs of the country (democracy) in which one was admitted must be learned within one year to such an extent that one can speak of a verifiably positive integration process. On the basis of "voluntariness" this will not happen. (Grading - and reward system develop!!)

Children and adolescents are required to attend school until they reach the age of 16 - directly followed by compulsory vocational training, an apprenticeship (3 years) or a one-year apprenticeship for a helper who can - but does not have to - lead to a proper apprenticeship.

There is an obligation to work.

- Those who aspire to an academic education must take an examination after completing their 10-year schooling (from 6 to 16) and the one-year vocational training year. After passing the examination, they can obtain the general higher education entrance qualification (Abitur) within 3 further school years.
- Education and training is an economically cost-intensive factor - therefore, every person living in the EU alliance states is a immigrant is obliged to work in the EU for 5 years after completing an apprenticeship or academic training.
- Immigrants who have also acquired an internationally valid EoE certificate during their school and training period can shorten the above-mentioned 5-year "blocking period" to 3 years.
- If every immigrant is aware of such a regulation (which must still be worked out in detail) before leaving the country, and knows that after three warnings he is threatened with expulsion to his



home country if he violates it massively, then integration is understood as a self-evident duty, not as an annoying MUST, which can be circumvented at any time by a medical note, or by immersion in another EU country, which is no longer so easy with the new passports.

- Only an immigrant who can give credible and complete evidence of his origin, his level of education and his political and economic ties in his home country is entitled to permanent admission to the EU after verification of his data.
- People who are unable to present such "certificates" must, for security reasons, be placed in a refugee reception center until their particulars have been checked. There, too, school attendance is compulsory.

The check must be completed after a maximum of one year.

If the verification criteria are met, they are granted official immigrant status, if not, immigrant status and continued residence are refused.

WHERE DOES THIS OPINION COME FROM?

It is a short quintessence from many hundreds of conversations with workers, pupils, teenagers, adults, students, teachers, university professors, doctors of medicine, philosophers, musicians, psychologists, futurologists, IT-educators, TV-people, artists, engineers, politicians, employees, CEOs of big companies, medium-sized entrepreneurs from the most different industries, administrative employees, like astrophysicists and road construction workers - Germans as well as foreigners from all over the world, from the cities and countries, in which I lived during the last 22 years, or which I visited for study purposes and lecture reasons.

Now the issue at stake is about an international EoE certificate, an additional "Abitur" exam, for longtime EoE students, that gets access to all universities in Europe, not only because it is an all-round exam in all EoE subjects, but also



because this exam is held in English, THE only language taught to children and teenagers from the beginning, using artificial intelligence (Avatars)

In addition, this new section should point out that the EoE knowledge transfer system will be available through the EoE platform in all countries of the world, so that EoE students, wherever they are, can participate actively or passively in this auto-active learning system at any time - a system where the latest world knowledge and its projections are always stored.

The EoE-System is also highly interesting in view of the ZEITGEIST-Problem of migration, which Europe will be confronted with again and again at present and in the next three or four decades... because even the rejected immigrant can "learn" in his home country, qualifying himself, and after two or three years of intensive "study" - with good prospects of success - he can try again to find his future in EUROPA.

It is a new, important paragraph for Eyes of Europe, as on the one hand it supports and confirms the new "Stress-Test article", and on the other hand it visibly expands the whole spectrum of the Eyes of Europe system.
